MANUFACTURERS' IDENTIFICATION OF AEROSPACE ELECTRICAL AND ELECTRONIC WIRING DEVICES AND ACCESSORIES

1. <u>SCOPE</u>:

This publication lists the symbols used by manufacturers of electrical and electronic wiring devices and accessories to identify their products that are within the scope of SAE Subcommittees AE-8Cl and AE-8C2.

These symbols appear on small wiring devices where the manufacturers' name (or recognizable portion) is not used.

2. PURPOSE:


The purpose of this publication is to provide users of electrical and electronic wiring devices and accessories a means of identifying the manufacturers of all such components by use of the symbology utilized by the manufacturers on their components.

3. GENERAL:

- 3.1 To be listed, the manufacturer should provide evidence that the symbol is used.
- 3.2 Provisions are made in most individual component specifications or standards for the specific locations of manufacturer's symbols.
- 3.3 The method by which manufacturers use to mark their products such as metal impression, etching, lazer, molded in marking (all preferred) and ink marking is a manufacturer's option.
- 3.4 The size of a manufacturer's symbol is also an option. However, the symbol should be legible with a maximum of four power magnification.
- 3.5 A request form for listing and changing symbols is provided at the back of the publication.

SAE Technical Board Rules provide that: "This report is published by SAE to advance the state of technical and engineering sciences. The use of this report is entirely voluntary, and its applicability and suitability for any particular use, including any patent infringement arising therefrom, is the sole responsibility of the user."

SAE reviews each technical report at least every five years at which time it may be reaffirmed, revised, or cancelled. SAE invites your written comments and suggestions.
